

## Introduction

The following is an introduction letter to someone whose baby needed a risky surgery. This family knew nothing about how to receive miracle from God. For now, this letter serves as an introduction to these Bible studies that show how to receive miracles faster. Only the basics are presented now. As I build this web site, I will present other studies that show how to get miracles to manifest faster.

As an engineer, I spent the past 29 years testing and studying the Bible to see if the Bible can be experimentally confirmed. I chose sickness/healing as the test venue, because it gives me many opportunities to run tests based on what I found in the Bible. I kept experimental notes for roughly the first two years only. After that, I only kept notes on unusual or outstanding healings. By then, I could get healing most of the time, or I understood why the experiment failed. I wrote Bible studies on important subtopics. Eventually, I wrote a rather large, but complete set of Bible studies on how to get the prayer of faith answered and how to get results to manifest faster than otherwise. I wrote this set for a family member who knew nothing about how to get her prayer answered. These studies are designed to be as self-standing as possible: one subtopic at a time with supporting Bible info around each subtopic.

A little sales pitch; some healing highlights:

(1) I hurt my left knee playing basketball in college (intramural) and could not run/jog because of the pain. Back then, knee surgery would leave me with a six-inch zipper scar. So, I waited and hoped. After some early apparent success, I used the knee as my target. Eventually, I could run fast break with my sons on the black top.

(2) I hurt my right shoulder swimming. I could not lift my right arm above horizontal, etc. I found out later that my symptoms match that of a typical rotator cuff injury. After several months of doing "faith" actions, I could do everything again.

(3) My mom had an aneurysm stroke and she initially could not move nor talk. She had blood in both sides of her brain. We prayed for her for roughly three hours per day for six weeks. Mom got everything back.

(4) My dad smoked all his adult life. After some tests, docs thought Dad had lung cancer and they cut out 1 lobe of his lung lobes. Dad was already taking treatment for asthma, and now he had lost 20% of his bad lung lobes. We prayed for Dad, mostly for his diabetes. But Dad did not have an asthma episode after the surgery. One day Dad told me that his doc told him that dad was growing a baby lung lobe. Doc showed Dad the x-ray too. Dad was in his 80's and was not a Christian. There are other such miracles.

Just a couple of Bible passages that say healing from God is for us today; they establish God's will for your baby and for us:

James 5:14 (KJS) Is any sick among you? let him call for the elders of the church; and let them pray over him, anointing him with oil in the name of the Lord:

15 And the **prayer of faith shall save** (heal) **the sick**, and the **Lord** shall **raise him** up; and if he have committed sins, they shall be forgiven him.

16 **Confess** [your] faults one to another, and **pray** one for another, that ye may **be healed**. The effectual fervent prayer of a righteous man availeth much.

James 5:15 is written for the church, for us today. Therefore, "the prayer of faith shall save the sick, and the Lord shall raise him up" is God's will for us today. The elders are to anoint the sick with oil to raise the sick up. Therefore, it is God's will that the sick be healed and be raised up. One way is through the "prayer of faith." This "prayer of faith" is shown to be Mark 11:24 elsewhere in these studies. And James 5:16 shows that the church is to pray fervently the "prayer of faith" for the sick to be healed. Romans 10:9-10 and 2 Corinthians 5:21 show that Christians are righteous when they accept Jesus by faith. God does not want us sick. God wants the children of God restored to health.

Proverb 4:20 My son, attend to my words; incline thine ear unto my sayings.

21 Let them not depart from thine eyes; keep them in the midst of thine heart.

22 For they are life unto those that find them, and health to all their flesh.

Many more such Bible passages are in the attached study, "**God Wants Us Healed.pdf**". They further establish God's will for your baby and us. This is important because once you know and are convinced that God wants good health for your baby, then all you have to do is to do "faith actions" and continue to do "faith actions" in agreement with God's will of good health for your baby. [See the "Bible Miracles Explained" and "What Jesus Means by Faith" studies.] God's will is established in the Bible. [See the other studies.] You and other intercessors keep on doing "faith actions" so that God's power continues to do what your "faith action" says. Do not stop doing your "faith actions."

Three Bible studies, **Bible Miracles Explained.pdf**, **What Jesus Means by Faith.pdf**, and **G54 To Call For.pdf**, establish the foundation that you need to really understand what the Bible says about how man gets miracles from God. They are very important. They are long to prove the point. For now, just skim them. We will get our miracle just like they did: by acting/speaking in agreement with God's will: that God wants your baby very healthy. It is important to note that they did not

ask/request for their miracles. They all acted in agreement with what God wants to give them. "Bible Miracles Explained.pdf" and "What Jesus Means by Faith.pdf" are the proof of this.

They show that man getting a miracle from God is a simple, three-steps process. These 3 steps are:

1. God declares God's will/promise towards man. God's will towards man is written in the Bible, but be sure to get the context right. [See the "Basic Verses Gods Will" and "God Wants Us Healed" studies.]
2. Man does (acts) in agreement with God's declared will in step 1. Man's belief in God's Word/declared will is necessary, but not sufficient by itself. Man must believe in God's declared will (that God does stand behind God's Word) and then take action in agreement with God's declared will. Speak/pray, listen, acts in agreement with God's will all count as man's actions in agreement with God's declared will.
3. God's power then implements the God's will that man acted in agreement with (in step 2).

The "Bible Miracles Explained" study shows 50 some pages of Bible episodes that show how these 3 steps work. These 50 some pages are the proof of this principle that you will use as well to get your healing miracle. Be sure to note that there are no "asking/request" from man. Instead, man knows God's will, does in agreement with God's will, and then God's power does what God said. Some skimming would show this principle.

The "What Jesus Means by Faith" study straightens a misconception and incorrect translation that "faith" means "believe." In the Bible, "faith" means "acting in agreement with God's will because man believes what God said about the issue." Again, this study has roughly 40 pages of Bible episodes that show this. Let the Bible interpret the Bible. This study supports the "Bible Miracles Explained" study. In turn, the "Bible Miracles Explained" study supports this study. Some skimming would show this principle.

The "G154 To Call For" study gives a more detailed breakdown to support these studies/principles above. Again, go with what the Bible shows. The roughly 90 pages of the above two studies are the proof.

For example, you and other intercessors saying the following faith statements will bring God's power to bear: [See the supporting studies.]

Father God, in the mighty name of Jesus, my baby is made whole. [The baby's heart (I think it was the heart?) is made healthy and whole.] The operation is super successful and the recovery is successful and miraculous. Thank you, God.

In Jesus' name, my baby is made whole [as used in Mark 5:34] and the operation is super successful. Baby's recovery is super successful. Your Word says so and I say so.

By the stripes on Jesus my baby is made whole and the operation/recovery are super successful. Thank you God.

Jesus has taken my baby's infirmity and sickness. My baby is made whole and the operation and recovery are very successful. Your Word says so and I say so. Amen

They all work. It is your speaking in agreement with God's will/Word that moves God's power to do God's will and what your faith says.

Remember " . . . according to your faith be it unto you," Matthew 9:29. If you do not do faith, God's power does not move. If you do faith, God's power does what your faith says. (See the Centurion's Servant miracle.) If you stop doing faith, God's power stops working, because you are not acting in agreement with God's will. Like when Moses lowered that rod, they were losing. When Aaron and Hur propped that rod up in agreement with God's will as stated in Exodus 4:17, they were winning again because God's power moved due to their faith action. So, keep on doing faith. **Do not stop**. More faith is better. Aaron and Hur helped Moses keep that rod raised. Get more people to do faith. More faith is better. [See the other studies.]

See Jesus keep on doing faith until the blind man sees clearly, in Mark 8:22-25. Do not quit doing faith. Especially when it seems dark. When it seems dark, skim the miracles and review how these people got their miracles to lift your spirit. This is how you build up your faith: Romans 10:17, Joshua 1:8, Proverbs 4:20-23. Stronger faith is better.

God's power moves to progress the miracle due to man's "faith" action is shown clearly in the episode of the woman with the issue of blood in Mark 5:25-34 (immediately below):

Mark 5:25 And a certain woman, which had an issue of blood twelve years,

26 And had suffered many things of many physicians, and had spent all that she had, and was nothing bettered, but rather grew worse,

27 When she had heard of Jesus, came in the press behind, and touched his garment.

28 For she said, If I may touch but his clothes, I shall be whole.

She did a Mark 11:23. She did not ask/request. She even qualified/controlled/limited her healing "faith" action. Her healing worked out exactly as she spoke: " . . . according to your faith be it unto you," Matthew 9:29.

29 And straightway the fountain of her blood was dried up; and she felt in her body that she was healed of that plague.

30 And Jesus, immediately knowing in himself that virtue (power) had gone out of him, turned him about in the press, and said, Who touched my clothes?

31 And his disciples said unto him, Thou seest the multitude thronging thee, and sayest thou, Who touched me?

32 And he looked round about to see her that had done this thing.

33 But the woman fearing and trembling, knowing what was done in her, came and fell down before him, and told him all the truth.

34 And he said unto her, Daughter, thy faith hath made thee whole; go in peace, and be whole of thy plague.

["be whole" in verse 34 (above) is used often in these studies. It means be restored to good health.]

The woman pulled power/healing out of Jesus (Acts 10:38), using only her faith. Jesus did not help her. Her healing worked exactly according to her "faith" action (Matthew 9:29). [See the "Illuminating Bible Passages" study.] Therefore, we use our "faith" to move power to obtain what God wants to give us, including those specified in the Lord's Prayer. (Matthew 6:33).

Before I quit, I want to point out the difference between what happened to James in Acts 12:1-2 versus what happened to Peter in Acts 12:3-12. Many were still praying for Peter deep into the night. Be sure that you fall in the Acts 12:3-12 case and not in the Acts 12:1-2 case. It helps a lot to know the other issues involved in getting a timely miracle from God. It also helps that others are contributing strong "faith" actions to your issue, like those Christians who prayed for Peter. [See the "Beat Short Deadline" study.]

This is the second email in this series.

The three Bible studies in the previous email are very important to getting miracles. They, using Bible episodes, prove that man gets miracles from God by doing "faith" actions in agreement with what God has declared in God's Word, the Bible, God's will towards man (us). It is very important to understand from these three studies, especially the "G154 To Call For" study, that it is our "faith" actions that progress the miracle God wants to give to us. Bible "faith" is not "believe." ". . . According to your faith be it unto you", Matthew 9:29 supports this. It is very important to study and understand these three studies thoroughly, because the Bible says what we get from God depends solely on our "faith" action (Matthew 9:29).

This email will address getting your needs met by implementing the three studies above. We will introduce a simple method that works without touching many subfactors, just to get started easily. At all times, remember that contradicting God's Word/will is a very bad idea. Don't do it.

These 3 verses (below) show how God views our words in our prayer of faith (Mark 11:24):

Numbers 14:28 Say unto them, As truly as I live, saith the LORD, **as ye have spoken in mine ears, so will I do to you:**

Numbers 14:28 says that God will do to us what we say in general or say in prayer. As always, we want to speak in agreement with what God says in his Word. If you study the situation surrounding Numbers 14:28, you'll see that those who disagreed with God's Word provoked God. Only those who agreed with God's Word received the manifested promise: go into the Promised Land.

The lesson here is to know and agree, in word and action, with what God says. More specifically, when you pray, tell God which part of His Word you are counting on to work. Jesus taught us/disciples to do this in the Lord's Prayer (Matthew 6:9-13). The Lord's Prayer consists of all Mark 11:23 statements that affirm God's will. More specifically, "give us this day our daily bread," "forgive us our debts," "lead us not into temptation," and "deliver us from evil" are all Mark 11:23 statements of God's will that change the world to conform to God's will. Speaking these clauses implements God's will to provide us sustenance, forgiveness, protection. God's will is determined from God's Word.

Isaiah 55:8 For my thoughts are not your thoughts, neither are your ways my ways, saith the LORD.

9 For as the heavens are higher than the earth, so are my ways higher than your ways, and my thoughts than your thoughts.

10 For as the rain cometh down, and the snow from heaven, and returneth not thither, but watereth the earth, and maketh it bring forth and bud, that it may give seed to the sower, and bread to the eater:

11 So shall **my word** be that goeth forth out of my mouth: it **shall not return unto me void**, but it shall accomplish that which I please, and it shall prosper in the thing whereto I sent it.

The second is Isaiah 55:8-11 (above). Verses 8-9 say that God's ways are not our ways. Therefore, we should pay attention to God's ways as described by God's Word. Verses 10-11 say that God sent His Word to us (regarding each specified topic such as healing for us, provision for us, protection for us, etc.) to prosper us. How? Verse 11 says that God's Word will be effective when we return it to God. How? God promises that God's Word will prosper us when we return (or affirm or agree with) God's Word to God in our prayer of faith.

Jeremiah 1:12 Then the LORD said to me, "You have seen well, for **I am watching over My word to perform it.**" (New American Standard, 1995)

The third is Jeremiah 1:12 (above), which is a repeat of Isaiah 55:11. Here God says that God is looking for people who expect God's Word/promise to be true and then God will perform His Word/promise to change the world to match His promise. An example of this is in Mark 16:20, ". . . the Lord . . . confirming the Word with signs following."

Numbers 14:28 says this method most clearly: we speak to God that we agree with God's will, and then God does his will that we speak in agreement with. God implements the miracle (that is in God's will) that we wanted. See Numbers 14:28 below.

Numbers 14:28 Say unto them, As truly as I live, saith the LORD, **as ye have spoken in mine ears, so will I do to you:**

From the study, "Basic Verses God's Will," we pull out God's will to supply our needs:

Philippians 4:19 But my God shall supply all your need according to his riches in glory by Christ Jesus.

Matthew 6:11 Give us this day our daily bread. 12 And forgive us our debts, as we forgive our debtors. 13 And lead us not into temptation, but deliver us from evil:

"God shall supply all your need" and "give us this day our daily bread" certainly include great job, more money, and adequate shelter. Given the above "our needs met" verses, you can now do "faith" action in agreement, by saying:

Thank you, God, in Jesus' mighty name, you said you supply all my needs. You keep my job going. You make my job the best job for me. You prepare me for my next great job and lead me to that job with more pay. You prepare the best shelter for me and lead me to it.

I think "faith" works better when we remind ourselves and God that we agree with God's will by putting God's will [here, it is: "you said you supply all my needs"] first in our "faith" statement. Speaking the prayer of faith in the above prayer is an action. It is acting in agreement with God's will towards you.

Because this faith action is in agreement with God's will, it is pleasing to God and we can, and should, do this "faith" action all the time. It is not "unbelief" to continually do "faith" action. We do "faith" action because we agree with God. God is pleased because we agree with Him. Also, we are not pestering God for our miracle. We confidently continually do "faith" action because 1 Thessalonians 5:17 says so. [See the "Illuminating Bible Passages" study.]

A glimpse ahead from the other studies and from the "Illuminating Bible Passage" study:

God declared God's will to Moses in Exodus 4:17, 3:8, 3:17. Moses did miracles by raising his rod, acting according to Exodus 4:17. To continually do "faith" action is like Moses holding the rod up all day so that God's power continues to help Joshua and the Israelites. When Moses stopped doing "faith" action (when Moses lowered the rod in Exodus 17:11), God's power stopped helping and the Israelites were losing. When Moses, Aaron, and Hur raised the rod again to agree with God's will in Exodus 4:17, God's power helped the Israelites again to implement God's will of getting them to the Promised Land (Exodus 17:8-13). [See the "Faith on, Power on; Faith off, Power off" portion of the "Illuminating Bible Passages" study.]

The important thing here is that when we do "faith" action (always in agreement with God's declared will), God's power moves to implement God's will. When we do not do "faith" action, God's power does not move/work.

]

So, keep on praying the sample prayer above. Once you know from the Bible God's will towards you, you can launch endless "faith" to manifest that miracle in your life. It may take a while. [See the "Jesus Paul Do More Faith" study.] You can see how I progressed in "dcEarlyPrayerLog" document. Also, It is very important to make your faith stronger (Romans 10:17). [See the "Fight the Good Fight of Faith" and "How Not Receive From God" studies.]

The following is from another email:

Once man knows God's will regarding the issue to be prayed for, then man's "faith" action allows God's power to progress the miracle that is in God's will. This is why not praying the "prayer of faith" does not initiate a miracle. Since man's "faith" action is always in agreement with God's will, then doing this "faith" action is not "unbelief." Continually doing this "faith" action is pleasing to God and allows God's power to continue to progress this miracle, until the prayed-for miracle manifests in our world. Jesus, in Mark 8:22-25, continued to do "faith" action until healing for the blind man fully manifested. It is also interesting that each time Jesus did "faith," some progress was made. This is the reason for 1 Thessalonians 5:17.

I stumbled across this principle when I was frustrated with healing for my left knee. [See the "dChenEarlyLog" document.] I did Mark 11:23 as Fred Price suggested for 1.5 year and my left knee seemed to waver: feels better, then worse, then better, then worse. I was ready to give up on this experiment. Then, I thought I would give it one last try. I thought that if something is good, then I wonder if more is better? So, I spoke healing verses at the left knee all day long, as much as possible. Then, I would test the knee a little bit. Two weeks later, I was jogging on grass without pain. As I kept on doing this, I eventually was running fast break with my sons on the black top. Even then, sometimes my knee would get sore. I would speak healing verses at my knee, and two days later I would be back running fast breaks. I have done this repetition of



“faith” action ever since. This has worked well. Eventually, I figured out the theory of why this works. It is sprinkled throughout this set of studies. Do not confuse Bible “faith” with “belief.”

Hagin said the same in his “Healing Scripture” book and CD. This is covered at the bottom of page 4 of the “Addendum to Healing Scriptures” study. Hagin did not give an explanation. Hagin’s testimony at page 6 of the “Addendum to Healing Scriptures” study says the same. Check out the “OTHER TESTIMONIES” on page 7 of the same study.

Remember, more and persistent faith actions are better. Also, make your faith stronger. See the “Jesus Paul Do More Faith,” “Fight the Good Fight of Faith,” “Illuminating Bible Passages,” and “The Big Picture” studies.

This will get your miracle started. We will cover other issues in other studies.

[All these studies are built on the Bible. Receiving miracle is difficult, simply due to ignorance of what the Bible says on this topic. You need to study all these studies to understand and put into your heart what the Bible says on this topic. The “The Big Picture” and “Fight the Good Fight of Faith” studies are especially important. If you are going to quit here, be sure to read “The Big Challenge” study to see why so many prayers fail.]

This is not a tutorial. Only the key Bible verses are listed. You may need to look up the context, the surrounding verses, to get the full message/meaning. The verses here are in the King James translation. Here is a popular Internet Bible with many translations and languages: [www.biblegateway.com](http://www.biblegateway.com). You may find translations such as NIV and AMP easier to understand. The Bible verses are in Courier New 11 font, and the clarifications that I inserted into a Bible verse are inside parentheses in italics. If you want more precise translation, go to [www.blueletterbible.org](http://www.blueletterbible.org), choose the King James Version (KJV), input the book and chapter, and turn on the Strong word option. The returned web page will show Bible verses as well as each word’s Strong number, its meaning, and cross references.

Also, using the name of Jesus to receive healing does not mean refusing medical care. You should receive medical care because God wants you healthy. But you should also use Jesus’ name to pray the prayer of faith to receive healing from God.

Lastly, these Bible studies do not address other Bible issues. Other issues are well addressed by other Christian sources. These studies only focus on how to receive miracles faster.
